On top of Saturday afternoon's expo, this year's National Forum will feature a number of short workshops aimed at assisting tracks and divisions across a wide range of areas. Face-to-face training sessions will be made available for new Officials and Junior Trainers, with workshops also available for at-track safety, applying for and securing grants, together with discussion relating to insurance and an open forum with the Speedway Australia board and staff.

### ESCAPE THE COLD AT THIS YEAR'S NATIONAL FORUM




There's no better place to be this June 19 and 20, with the National Forum being held at the beautiful Gold Coast Convention Centre – right in the heart of Broadbeach.

# ONE DAY BULK OFFICIALS' LICENCES NOW AVAILABLE ONLINE!



The purchase of one day bulk officials' licences currently requires a venue to email the office well in advance, who arrange an invoice for payment and create a spreadsheet that is sent to the track to print out.

We're pleased to advise you can now do these online, in your own time and get instant processing and paperwork. The link to purchase these online is available here.

This licence is designed to be purchased by venues to cover track officials who may change from time to time, and who don't have an annual \$25 Officials licence. Each

licence costs \$6 per night and is valid for the date stated on the form only. A two-day meeting requires two payments. It provides complimentary personal accident insurance cover, in accordance with the standard <u>schedule of benefits</u>.

When you complete the form and pay for the licences, a pdf will be generated and emailed that mirrors the spreadsheet that tracks receive when they contact the office directly. This is how you identify the officials who are utilising this service and sign them into the scheme.

We've worked really hard over recent years to automate processes and reduce the number of items tracks are required to prepay in advance, and this is the latest on the list.





### **VICTORIAN CLUBS: CONSTITUTION CHECK**

In 2012 the incorporated associations legislation in Victoria was overhauled, in order to modernise and standardise the function of not-for-profits in the state. Clubs are now either operating under

- Their own rules (if they were submitted to and have been approved by Consumer Affairs Victoria), or
- 2) The model rules (if the club agreed to change to these), or
- 3) Under their existing constitution that is overridden by the model rules as appropriate (if the club did nothing).

The reason we mention this today is that with the passing of time it may not be apparent to existing club members what the exact status of the constitution is. And this can become important when issues arise around disputes between members and/or the club executive, as the model rules have specific appeal processes that can't be opted out of, for example.

You can check the status of any club via this link, and the public register will note whether a club's constitution is in force, or whether the model rules apply (as per below)
