### RODRIGUEZ RETURNS TO RACING

Victorian Speedcar and Compact driver Louis Rodriguez has been missing from the starting grid for the past six weeks, but is looking forward to returning to racing this weekend at Avalon Raceway.

Louis was selected for random drug testing when Speedway Australia visited the same venue in late October, and returned a non-negative result. Investigations revealed Louis was on a prohibited medication he had been prescribed by his doctor, and he hadn't undertaken the Therapeutic Use Exemption (TUE) process to obtain a racing licence.



As per the rules, Louis was immediately suspended from all competition and appeared before a judiciary tribunal. He also organised his TUE paperwork, which enables him to return to racing with approved levels of a prohibited medication in his system.

Now that his suspension is almost over, Louis is keen to help others avoid the same fate as him. "I'm disappointed in myself for not keeping up with all the rules and regulations that are required for me to hold a Speedway Australia license" said Louis. "I can't apologise enough for putting you all through this as I know it wouldn't be easy to suspend someone's licence on the spot."

We thank Louis for his honesty and commitment to putting things right. And we urge all competitors to ensure that they obtain the necessary permission if required. If you're not sure about your medication you can check the suitability of a substance via the following Australian government website:-
