


SPEED ENEWS EDITION 31 | 19 OCTOBER 2018

PREVENTING BULLYING

Our Speedway staff and other licence holders have noticed of late some obvious bullying taking place, particularly through social media. As you'll all be aware, we do have a social media misconduct process which unfortunately we've needed to use multiple times this year. However, we need the whole sport to take a stance against bullying to truly wipe it out.

Bullying isn't just between youth but can also be conducted between adults. Name calling, mocking someone, spreading rumours or lies or harassing someone based on their race, sex, religion, gender or disability are just some examples of bullying.

The Speedway Australia team needs the support of all tracks and divisions to crack down on this wherever possible. Making matters worse, we have seen on multiple occasions people being bullied from individuals who are executive committee members in organisations within the sport. This simply

isn't acceptable and people leading all organisations need to set the example. When people in positions of power bully, it can be even more disastrous for the victim, giving a feeling of having nowhere to go to for support.

It's important that everyone within the sport takes notice of any bullying and helps us stomp it out where possible. If you see any examples, please forward any information, screenshots or videos to us to investigate. All licence holders are subject to Speedway Australia's rules & regulations.

STEWARDS & ACCIDENT/INCIDENT REPORTS

Following every event, please ensure your steward is supplying our office with their Stewards Report.

Also, if there are any accident/incident reports, it's extremely important that we receive these promptly. We need these reports in the event of any claims or queries to cross check information received – and speed up the payment process to injured licence holders.

OFFICIALS CARD REBATE

We have received some confusion of late from those holding officials cards as to how the rebate works. Only stewards and scrutineers are eligible for this \$90 rebate, once their steward or scrutineer cards have been issued.

If licence holders only hold a grey official's card, they are not currently entitled to this rebate. This includes the likes of people in positions such as flag marshals, race secretaries, gate staff, pit management etc.

Please educate your relevant individuals so they are aware of this.
