# Gallagher

After last week's announcement of Arthur J Gallagher being appointed as Speedway Australia's broker, Speedway Australia and in particular Mark Holmes have been hard at work behind the scenes ensuring the transition is seamless for venues across Australia.

In the meantime, we've had a handful of enquiries regarding current outstanding invoices and other products which Tracks, and Associations have with various insurers. Some of these include;

### **Speedway Liability Insurance Race Meeting Invoices (September Only)**

Tracks who have unpaid invoices issued by Marsh for **September only** meetings need to pay those invoices to Marsh in the usual manner. **Please ensure that you email the transaction receipt to Marsh, with copies to Mark Holmes and Liz Weaver.**

If your track requires a new invoice for a **September** meeting, please email the request with date and category directly to Mark and Liz at Speedway Australia (**not Marsh**) who will arrange a Gallagher Invoice.

### **Associations Liability/Management Liability Policies.**

Not to be confused with The Speedway Public Liability policy, a number of Tracks, Associations and Clubs hold a policy brokered by Marsh Finpro Adelaide. These policies are not subject to the new appointment to Gallagher as they are not a Speedway Australia administered program but rather a relationship between the Tracks etc and Marsh Finpro.

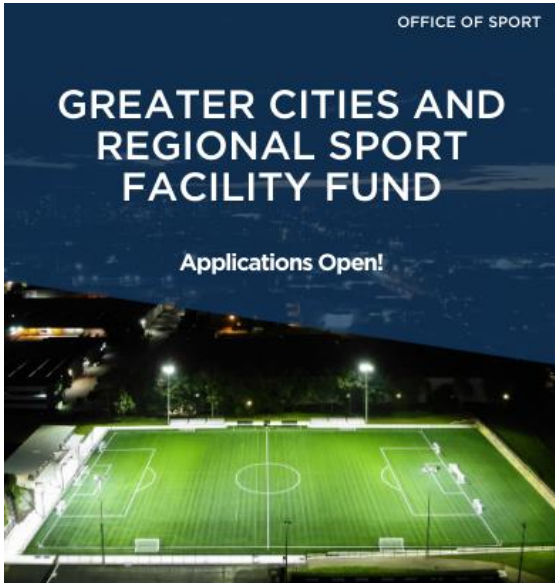

### **Voluntary Workers Personal Accident Policies.**

Up to 40 Track venues hold a separate standalone policy brokered by Marsh. As such, they are not subject to the Speedway Australia agreement with Gallagher. You may elect to continue dealing with Marsh on or seek a quotation from Gallagher. If you require further information about Gallagher, please contact me in the meantime for referral.



## EXCITING GRANT OPPORTUNITIES FOR NSW TRACKS



It's been a difficult few months for NSW venues, with a state-wide lockdown preventing much of the pre-season preparation and working bees which would see tracks ready for the upcoming summer of speedway. There is light at the end of the tunnel however, with the NSW Government outlining a roadmap to recovery, seeing Recreation Facilities (Major) return to capacity once the state reaches the 70% vaccination milestone – albeit with a 1 person per 4sqm rule in place.

Meanwhile, a new grant has just been released that all NSW tracks are eligible to apply for, the Greater Cities and Regional Sport Facility Fund. There's \$100 million up for grabs over two-years to support new and upgraded sporting facilities in NSW. Of note, all organisational types including for profit businesses are eligible. Applications close October 8<sup>th</sup> so act now!
