ASSISTING WITH HELMET QUERIES



Quite often we receive phone calls in the office from drivers and scrutineers who aren't clear as to the requirements of the Racing Rules and Regulations in regard to helmets – in particular, which helmet may be suitable for their applicable racing division, and when might they be required to replace that helmet.

In the past we have put together written pieces to assist clubs and drivers in choosing the right helmet for their intended use (such as issue #59 of eNews which can be found here), however to assist clubs, in particular scrutineers in identifying the correct helmet, we have assembled a handy graphic which can be found on the final page of this edition.

KART PIT AREAS



This week we'd like to give all Tracks and Clubs running Karting events a quick reminder of rules relating to Pit Health and Safety, and how they apply to Karts.

Section 3.7 of the Speedway Australia regulations state make minor allowances for Karts in the Pit area, in particular the rules relating to fire extinguishers (not required by SKAA competitors) and Quad Bikes in the pits. Section 3.7.6(a) states; -

3.7.6(a). NOTE: For SKAA Speedway Karts, 3.7.6(a) does not apply when push starting from the pits. Instead a clearly defined hot area (rope barriers etc), set as the shortest practical distance from pit to track i.e. directly in front of chute/track entry gate. The official in charge of the pit gate is to ensure that the area is completely clear before giving the call to start a race.

A few clubs have enquired as to whether this rule above means the Pit Health and Safety rules only apply to the hot area for the duration of the race meeting. This is most certainly NOT the case, with Section 3.7 applying to the entire pit area, just like any other Speedway Australia event. This also includes the rules relating to alcohol and drugs, abusive behaviour or misconduct, and the requirement for everyone within the pit area to hold an annual Speedway Australia licence, or one-day licence.
