## **eNEWS AND STAND DOWN LIST CHANGES FROM NEXT WEEK**



In order to relieve some of the pressure on track administrators, the eNews and Stand Down List will be published on a Wednesday afternoon from next week onwards.

Often, track personnel are busy preparing for the weekend's event when the eNews and Stand-Down list are sent out, leaving it unread, or irrelevant by the time they get to read it after the event.

Furthermore, racers who have been added to the Stand-Down list will be given a few days notice before a potential race meeting rather than arriving at an event to find they are not permitted to race.

As a result, the infringement process will now require a weekly deadline to be included in the Stand-Down list that week. **Speedway Australia must be informed of an**

**infringement by start-of-business Tuesday morning to allow time for processing and the offender to be notified by email before the new Wednesday afternoon publishing time.** Any infringement correspondence with Speedway Australia that misses the deadline will be carried over to the following week.

Please also note that from this week, the Stand Down list will now be presented in alphabetical order with surname first for easier access for administration staff and volunteers. New additions to the list will be in **red**.
