Although the refund and transfer policy is clearly noted in every Day Licence email, we still get many enquires. Hopefully this below will explain why the policy is in place.

Once a race meeting has commenced and the licence holder has signed in under the Day Licence and entered the red zone of a venue, regardless of if they get to race or not the licence is activated and covers them for any accidents.

This is no different to if you purchase a ticket to an event like a concert. If the licence holder finds they can no longer attend they are not entitled to a refund or transfer.

EXCERPT FROM THE DAY LICENCE EMAIL

PLEASE NOTE

Only under circumstances where the race meeting is cancelled prior to commencing will you be entitled to a refund or transfer of your Day Licence. If the event is cancelled and you would like your Day Licence transferred you must reply to this email giving at least 5 business days notice for the transfer to be made.

STEWARD AND SCRUTINEER CHECKS



We are finding many venues and divisions are allowing standard officials to Steward or Scrutineer. All Steward and Scrutineers must hold a licence, but they also need to obtain a Steward or Scrutineer Card. Steward and Scrutineer Cards are issued at no cost they just need to be applied for and approved by the club / division.

PRACTICE AND TRACK PERMITS



All race meeting dates are normally declared on a Track Commitment Form forwarded to Marsh Advantage at the beginning of the season. With invoices being issued by Marsh Advantage roughly a month in advance.

Any race meeting dates or alterations not declared on the Commitment Form should be declared in writing by email to Mark Holmes at Marsh Advantage as soon as possible but ideally no later than 2 weeks prior to the event date along with a payment remittance emailed to Mark Holmes.

We understand that sometimes these things are overlooked but too frequently we are receiving permit requests with a day's notice or payment after business hours on a Friday night. Without a permit or insurance your event shouldn't go ahead therefore it should be one of the first things you organise when planning an event.

Practice Permits are complimentary as long as there is no admission to the general public, paying or not. If you plan on opening your gates to spectators, you will need to be invoiced by notifying Marsh Advantage. Marsh Advantage issue an Executive Summary to all tracks at renewal time. We recommend you read this thoroughly as it explains the practice permit and other common procedures.

Practice Permit requests need to be emailed to Speedway Australia with at least 5 day's notice. The concession for Practice Permits allowed by insurers is intended for imminent paid race meetings and should not exceed the number invoiced race meetings.

SOCIAL MEDIA MISCONDUCT



Earlier this season, an update was made to the rulebook in regards to the process of dealing with potential social media misconduct. Rule 7.6.6 gives an overview of this process, including the seven grades of severity and the relevant penalties attached to each.

As mentioned in last weeks edition of Speed eNews, Speedway Australia is taking social media misconduct very seriously and we

have been dealing with a large amount of potential infringements over the last few weeks. We can now confirm the following penalties have been delivered;

• **Grade One** | Four infringements

• Grade Two | One infringement

We are pleased to say that two of these infringements were reduced one grade due to compliance with rule 7.6.6 (i), showing licence holders do realise the importance of this issue.


